



Media Consent Agreement  
FEQ Festival d'été de Québec

**PARTIES TO AGREEMENT:** This limited agreement is by and between FEQ Festival d'été de Québec, its organizers and duly authorized representatives, including any, and all, Third Party Media entities whose signature/signatures appear below that have been permitted to cover the Festival.

- Permission is hereby given with caveats to FEQ and all directly authorized and affiliated media professionals for Photo and Video capture/coverage of the band SAGA, during their performance and appearance at the Festival.
- Photography/Still/Onsite broadcasts, projection – *kindly avoid* shots of the band members with unsightly perspiration or other aesthetic issues, s'il vous plait.
- No candid/off-stage shots of the band members may be taken without the awareness of the subject at the time of image capture. No photos/videos may be captured of the artists smoking or consuming alcoholic beverages, whether in their private artists areas or the Festival grounds.
- Promotional clips or reels *may not* be composed of an entire song/s and may be used solely for FEQ or SAGA
- Interviews - photography or videography shall allow the artist/individual to express their personal comfort needs (standing, sitting, preferred angle) as the case maybe.
- All promotional use/social media posts, reels, stories, etcetera, *is permitted* on a mutual release basis. This extends to the band's personnel and shall include the proper credit to the authors and artists with appropriate meta tags.
- Photographers/Videographers may have editorial use of any images of the band's performance or artist interviews for their direct affiliated press organizations, provided that no other monetization occurs, including, but not limited to, digital repositories/media banks, physical prints, or non-fungible blockchain tokens and any other form.

**AUTHORITY TO ENTER INTO AGREEMENT.** The persons signing this document have the full right and authority to enter into this Agreement on behalf of the Parties, and the full right and authority to execute said instrument, and to fully bind the Parties to the terms and obligations of this Agreement, and that it has not heretofore assigned, encumbered, or in any manner transferred, to any third person, or entity, not a Party hereto, or an attorney for a Party hereto, all, or any portion, of the claims covered by this Agreement.
